Christine Kerr will report back progress at the next meeting in relation to the "Narrowing the Gap" work programme commissioned by the Board at its last meeting. 9. Draft Virgin and London Midland Timetable from December 2008 Nick Gower-Johnson confirmed that an email had been sent conveying the feelings of the PSB, which will be followed up with a formal letter. **Area Based Grant** Oliver Winters presented a report on the Area Based Grant. The key points of the report were highlighted: The ABG for Warwickshire is £22.1m for 2008/2009 • There is a significant increase in coming years due to the inclusion of the Supporting People Grant Appendix A of the report gives the detail of the ABG for 2008/09 to 2010/11 • Grants are no longer ring fenced and could in theory be used for other purposes · Warwickshire County Council is responsible for finalising the allocation of grant in consultation with the PSB • Table 2 outlines the timetable for taking the process forward, it is a challenging timetable and hopefully next years timetable will be more realistic • This year is viewed as a transitional year • With the exception of one grant 'Social Community Cohesion in Nuneaton & Bedworth' there does not appear to be any new/additional resource. There followed a discussion on the report with the main queries being: SS • Clarification is needed on the Social Cohesion Grant for Nuneaton & Bedworth. Sharon Shattock will investigate this issue with the GO Cohesion Team. Timing and flexibility issues – Budgets will be set in March, while targets are not officially signed off with GOWM until May. There is a built in review date in the New LAA for October 2008, giving opportunity to address issues around misalignment of resources Issues on funding current projects and contracts. Block Leads had responded to the request made at the last PSB meeting to identify funding/gaps pressures that could be supported through any projected underspend in 2007/08. Oliver reported that it was now most unlikely that there would be any significant level of underspend this financial **OW**

4a	Index of Multiple Deprivation (IMD)	
	Spencer Payne presented the initial analysis undertaken by the Warwickshire Observatory on the IMD. The IMD was published in December 2007. More detailed analysis will be undertaken over the next few weeks making the links to the Narrowing the Gap work. The initial findings show that certain districts and localities in Warwickshire have got worse and a greater number of these areas appear in the top 10% Nationally deprived areas. In the Super Output Areas Warwickshire used to have 2, this has increased to 8 – all in the Nuneaton & Bedworth area.  The group welcomed the report, thanked Spencer and posed the following issues:  Has N&B got worse or have other districts improved?  The gap has got wider and needs to be addressed and more analysis undertaken  Need to address vulnerable groups in the deprived areas  Appendix 2 - very interesting to see LAA Block comparison between this and the last IMD  The impact of Camp Hill regeneration may not be reflected in this report due to the age of the data  Data shown on 1st Page of the report is 2 -3 years old	
4b	Story of Place	
	Spencer Payne presented the draft report on the 'Story of Place'. Developing a Story of Place for Warwickshire is critical in the development of the new LAA and will act as part of the evidence base for developing priorities within the new LAA. This first draft will provide baseline information and context for the Blocks. Spencer asked for general and block intelligence feedback which will be incorporated into the report  The group welcomed the report, thanked Spencer and posed the following issues:

#### 5 Priorities for the new LAA

Nick Gower-Johnson introduced this item by saying that the development of the new LAA is an opportunity to rationalise and prioritise the current Agreement, build on the progress that has been made on the key theme of Narrowing the Gap, and enhance the coherence of the LAA across its current six Block Structure.

All Theme Groups have been very active over the last few weeks and have meet to discuss the draft priorities for inclusion in the new LAA. Each Block has submitted their choice of draft priorities to Nick Gower-Johnson and these were combined into one report and circulated before the meeting. The PSB needs to agree the basket of draft indicators before they are presented to GO. The Blocks have so far suggested a total of 36 indicators drawn from the National Indicator Set. The task of the Board is to prioritise this list of 36 to a shorter list which will be used by the Blocks as a basis for their delivery and resource planning, and for wider partner and elected member engagement.

It was agreed that each Block Lead should be given 10 minutes to outline the draft priorities emerging from their Block (see Appendix 1) and the reasoning for the choices. The following specific points were raised in relation to Appendix 1 attached:

#### 1) Children & Young People – Geoff King

- NI 156 Number of households living in Temporary Accommodation – not sure that this relates to children only, households may not include children –look at
- Why isn't teenage pregnancy more visible? It has been included as part of NI 50 Emotional Health of Children
- NI 69 Children who have experienced bullying is felt to be important and could be put under the Stay Safe Priority

#### 2) Safer Communities – Andy Parker

- NI 15 Serious violent crime rate this includes Domestic Abuse
- NI 30 Re-offending rate of prolific and priority offenders is key

#### 3) Stronger Communities – Chris Elliott

- NI 155 Number of affordable homes need for all authorities to sign up to this in terms of land value/sale, otherwise target will not be achieved
- NI 14 Avoidable contact, the need to marry up outreach with avoidable contact
- NI 6 Volunteering at least once a month why was this one chosen and not a more challenging one?

#### 4) Healthier Communities & Older People – Tim Davies

- Should Carers and Mental health be brought into the current priorities, they will have to be local indicators. NI 124 People with a long-term condition supported to be independent and in control of their condition and 139 The extent to which older people receive the support they need to live independently at home - must involve services/delivery around carer support
- Query on NI 187 Tackling Fuel Poverty should this be included? And if yes where? Under HCOP or CC&E, it could be a local indicator
- There is an overlap of the Supporting People Indicators, maybe match up NI 124 and NI141, NI139 and 142
- NI 120 All age all cause mortality should this include infant mortality which is a traditional indicator of poverty?

#### 5) Economic Development & Enterprise - Dave Hill

- Add to the first objective " ....while increasing overall Economic Performance"
- Top priority should be worklessness plus up-skilling
- NVQ level 2 could be included in the basics skills agenda as well as the higher levels i.e. 4
- Need to focus on the skills gap NI 174 would cover this –
   Skills gaps in the current workforce reported by employers

#### 6) Climate Change & Environment – Christine Kerr

- Should Fuel Poverty be included either here or elsewhere?
- Should an indicator on flooding be included, query on NI 189 Flood and coastal erosion risk management – Sharon GOWM said in order to use this indicator you have to have a coast line! But she will investigate and feedback to NGJ

 Query on why waste was not included as the County is below average performance – considered that this is **Block Leads** 

covered in the work of the 'Waste Partnership'

 NI 195 Improved street and environmental cleanliness (levels of graffiti, litter, detritus and fly posting) is an important indicator especially at a local level

#### Resolved:

That Block Leads be asked to discuss and address the issues within their blocks and report back to Nick Gower-Johnson week beginning 28<sup>th</sup> January.

The group recorded their thanks to the Themed Groups, Block Leads and all those involved in this process for providing an excellent starting point as a result of generally exhaustive and inclusive processes.

In response to a query raised by Nick Gower-Johnson, Sharon Shattock agreed that it would be entirely appropriate for the submission due by 31<sup>st</sup> January to effectively represent the sum total of progress to date. She acknowledged that this would be subject to further refinement, partner discussion and, importantly, engagement with elected members.

#### 6 Consideration of the Timetable for agreeing the new LAA

Nick Gower-Johnson outlined the next steps:

- A provisional list of up to 35 indicators will need to be submitted to GO at the end of January
- Block leads to discuss the queries above and respond to Nick Gower-Johnson week beginning 28<sup>th</sup> January 2008
- Nick to undertake a rationalisation exercise on the priorities submitted and analyse the overall view of the priorities
- The draft priorities to be circulated to the PSB
- Draft priorities to be submitted to GOWM end of January (subject as above)
- Identification and agreement of resources required by the new LAA Negotiation of Targets over the 3 years of the new LAA with partners and GOWM – Feb/March 2008
- Submission of near final draft to GOWM 31<sup>st</sup> March 2008
- Finalisation of negotiations with GOWM and central government March/June
- Sign off with central government July 1st 2008

## 7 Coventry and Warwickshire Infrastructure Consortium (CWIC)

William Clemmey informed the group that CWIC have produced a Six Year Strategy plus a Three Year Business
