Waste Management Targets for Local Area Agreement

Report of the Strategic Director for Environment and Economy on behalf of the Officers Group

Summary

The report discusses Local Area Agreements and proposes targets for Waste Management.

Recommendation

That the proposed targets detailed in paragraph 4.1 be endorsed.

1. Introduction

- 1.1 As Members are aware a Local Area Agreement (LAA) is currently being prepared. It will cover the three years 2007/8 to 2009/10.
- 1.2 The Government has set out a wide-ranging and systematic framework for priority outcomes for LAAs around 4 blocks: Children and Young People; Safer and Stronger Communities; Healthier Communities and Older People: Economic Development and Enterprise. A number of these priority outcomes (and supporting indicators) must be reflected in the LAA. Waste Management is included in the Safer and Stronger Communities Block.

2. Waste Management Outcomes

- 2.1 There are two mandatory outcomes for Waste Management, increasing recycling and reducing waste to landfill. The associated indicators are:-
 - (a) Reduction in the percentage of municipal waste landfilled.
 - (b) Increase in the percentage of municipal waste recycled.
- 2.2 It is interesting to note that the indicators refer to municipal waste rather than household waste. Municipal waste is basically household waste, plus the trade waste accepted at transfer stations, plus the trade waste collected by the District Councils, plus the soils and rubble separated out at Recycling Centres.



3. Funding and Rewards

- 3.1 One of the main changes introduced by the LAA is that certain funding streams will be pooled and given to the County Council for distribution to the partners in accordance with the terms of the LAA. For Waste Management the Waste Performance and Efficiency Grant (WPEG) will be pooled. In 2007/8 this will amount to £1,118,426.44. The Government has yet to announce the level of WPEG (if any) for 2008/9 and 2009/10.
- 3.2 It is also intended to combine Legal Public Service Agreements (LPSAs) and LAAs. All new LPSAs will be incorporated into LAAs as the reward element. The County has negotiated a new LPSA and the outcomes concern the tonnage of non-biodegradable household waste recycled. If the target is achieved then the Performance Reward Grant is likely to be about £1 million. The final year for the LPSA is 2008/9 and any reward grant is not expected to be received until 2009/10. The formula for distributing this to the partners has yet to be decided. District Councils will shortly receive a draft of the Partnership Agreement for the LPSA.
- 3.3 The LPSA target is to recycle 23,000 tonnes of non-biodegradable household waste (primarily glass, metals, electrical goods, plastics, 50% of textiles) in 2008/9.

4. Proposed Targets

4.1 Officers have already fed proposed targets into the LAA preparation process. These are:-

4.2 Full details of how these figures were calculated are detailed in **Appendix A**. The main assumption is that waste will only increase at the same rate as



population. This is a challenging target since in the past, excluding the 2005/06 outcome, waste has on average increased by 2% more than the rate population has increased.

4.3 If the LAA targets are achieved then this will mean our Waste Strategy target of recycling and composting over 40% of household waste by 2009/10 will also be achieved. We will also landfill less than the statutory maximum of 113,495 tonnes of BMW (Biodegradable Municipal Waste) in that year, which is the first key EU target year for landfill diversion.

Assumptions

- 1. 1.0% per annum increases in waste, to correspond with population increase. 3% increase per annum in recycling and composting from 1.4.2006.
- 2. Quantity incinerated at Coventry is assumed to be 21000 tpa from 1.4.06, and 40,000 tpa from 1.4.09.
- 3. An extra 2,000 tpa of green waste collected by NWBC from 1.4.06.
- 4. An extra 2,000 tpa of green waste collected by Rugby from 1.4.06
- 5. An extra 2,500 tpa in green waste collected by Warwick from 1.4.08
- 6. An extra 8,000 tpa composted from 1.4.09 due to the collection of kitchen waste
- 7. An extra 3000 tpa recycling by Warwick due to alternate weekly collections from 1.4.08
- 8. An extra 5,000 tpa recycling from 1.4.08 due to introduction of Rugby's MRF and alternate weekly collections.
- 9. For municipal waste, for recycling and composting, it is assumed that the quantity recycled and composted is the household waste treated as such plus one third of the difference between municipal and household (mainly inerts recycled).
- 10. For landfilling with respect to municipal waste, it is assumed that two thirds of the difference between municipal and household is landfilled.

INVITATION TO SUBMIT PROPOSALS FOR POOLING ARRANGEMENTS RELATING TO STATUTORY PERFORMANCE STANDARDS FOR RECYCLING AND COMPOSTING OF HOUSEHOLD WASTE FOR 2007/08

Following the announcement on 15 May on local authority recycling and composting targets for 2007/08 and the continued interest in pooling from local authorities as expressed in the recent consultation, Ministers have agreed that authorities should be given the opportunity to amend their statutory performance standards by entering into pooling arrangements for 2007/08.

Pooling these targets allows groups of waste authorities to work together to achieve Best Value by changing the individual levels of recycling and composting required of each of them. It aims to provide a formal mechanism for authorities to work together where it is agreed mutually that the arrangement will help achieve Best Value.

For the 2003/04 and 2005/06 statutory performance standards for recycling and composting of household waste Defra invited proposals from local authorities for

Date: 05/10/2006 Author: mstemp1 pooling arrangements which led to a number of successful pooling proposals authorities and subsequent amendments to their Statutory Performance Standards.

To avoid any confusion, I must underline that although the intention of pooling is to achieve collective responsibility through partnership working, <u>each authority</u> within the pool should retain its own individual Statutory Performance Standard (albeit modified by the pooling arrangement) and would be responsible in law for the contribution it is making to the pool.

Since pooling arrangements are likely to be underpinned by close partnership working between authorities, perhaps supported by a Joint Municipal Waste Management Strategy, authorities may feel there is no need to formalise their collective responsibility. Where authorities feel it is necessary, however, they might enter into contractual arrangements to underpin partnership working. The Government does not intend to advise, or put forward guidelines, on such contractual arrangements.

Authorities proposing to pool their Statutory Performance Standards will need to demonstrate that as a result of the partnership working that underpins the pooling arrangement, the overall tonnage of waste recycled by the pool as a whole will be greater than that which would be recycled in the absence of the pooling arrangements. We will not accept any individual Statutory Performance Standard within the pool lower than 20%.

I am therefore inviting you to send proposals for pooling arrangements relating to your statutory performance standards for recycling and composting of household waste for 2007/08. I attach guidance on pooling arrangements and submitting proposals. Proposals should be submitted to Philip Walker (see the guidance note for his address) collectively by groups of authorities wishing to pool their standards by 20 October 2006

This procedure applies only to targets on 2007/08. Local authority waste performance targets after 2007/08 are under review as part of the revised waste strategy, due to be announced later this year, and the Department for Communities and Local Government's review of the local government performance framework.

Guidance for local authorities in England on POOLING arrangements relating to Statutory Performance Standards for recycling and composting in 2007/08

September 2006

What does pooling achieve?

Pooling will allow groups of waste authorities to change the individual Statutory Performance Standards for recycling and composting required of each of them. It aims to provide a formal mechanism for authorities to work together where it is agreed mutually that the arrangement will help achieve Best Value. Although legally each authority in a pool will retain responsibility for a new Standard, the aim is to work together to achieve an increased level of recycling in a group of pooling authorities.

How can pooling benefit authorities?

Pooling can enable authorities to plan better improvements and investments in recycling of household waste collected through kerbside collection or bring sites. In turn, it can also lead to investment in, expansion of, and better management of the civic amenity sites by waste disposal authorities.

What are the basic requirements of pooling?

Authorities proposing to pool their Statutory Performance Standards will need to demonstrate that as a result of the partnership working that underpins the pooling arrangement:

- the overall tonnage of waste recycled by the pool as a whole will be greater than that which would be recycled in the absence of the pooling arrangements and that
- the new arrangement would contribute towards each authority's obligations under Best Value of securing continuous improvement.

By requiring the overall tonnage of waste recycled to increase it is intended to mitigate the risk that the statutory performance standards for most authorities may reduce in return for large increases in waste recycled at civic amenity sites – run by waste disposal authorities and a part of the calculations of only a waste disposal authorities.

How should I decide whether to consider pooling?

It is a matter for the waste authorities involved to consider whether pooling will be helpful for them. We encourage:

- solely waste collection authorities to pool their targets with their waste disposal authority to spread more evenly the burden across the area. Where applicable we would also encourage neighbouring or partner unitary authorities to enter into such arrangements; and
- applications from neighbouring unitary authorities

Who should submit proposals to pool?

Proposals should be submitted by groups of authorities. Any group of English waste authorities with Statutory Performance Standards for recycling and composting of household waste will be eligible to propose a formal pooling partnership to the Secretary of State.

How many pooling arrangements were agreed in 2003-04 and 2005-06?

A list of authorities who previously pooled their standards is included at **Annex A.** Five areas agreed to pool their targets in both target years: Greater Manchester, Somerset, Wiltshire, Merseyside, Oxfordshire. The authorities in Nottinghamshire agreed to pool their targets only in 2003/04.

How will the Government decide if our proposal is acceptable?

The Secretary of State retains discretion to accept or reject proposals. Where the Government is satisfied that pooled arrangements will contribute or lead to Best Value, each authority's individual Standard may be changed.

In some circumstances the Secretary of State may wish to increase the proposed Standards to ensure that no decrease in recycling occurs when compared with the original Standards, e.g. if assumptions of growth in waste arisings are not robust. Where this is the case each pooling group will have the opportunity to accept or reject the proposals.

Please note that the pooling arrangements must provide for an improved overall recycling performance for the group as a whole and that no individual authority's Performance Standard should be below 20% as a result of the pooling agreement. See **Annex B** for list of targets for 2007/08 (subject to any pooling arrangement).

When will we find out if our proposal is accepted, and when will our Statutory Performance Standard be changed?

We aim to have considered proposals and set out the Department's view on whether the proposal is acceptable by 10 November 2006 All local authority Statutory Performance Standards for recycling and composting (including the revised pooled standards) will then be given effect by a statutory instrument to be introduced at the start of the 2007-08 financial year.

What should your proposal contain?

<u>Please submit your proposal on no more than 5 sides of A4 following points 1-6 below.</u> If we need further information we will contact you.

- 1. Please set out the <u>contact details</u> for the officer or officers with lead responsibility for submitting the proposal, including name, telephone number, e-mail and address.
- 2. The Secretary of State may decide to alter the Statutory Performance Standards for a group of authorities if satisfied that the pooling proposal demonstrates the arrangements will lead to Best Value. Pooling proposals must include an explanation of why this will be expedient to achieving Best Value, assessed against the Best Value criteria of securing continuous improvement for each authority in a pool in the way that that authority exercises the waste function, having regard to a combination of economy, efficiency and effectiveness.
- 3. Authorities should base their calculations on the most appropriate data in order to reduce the risk of incorrect predictions and subsequent impacts on future levels of recycling. Evidence supporting assumptions about future tonnages should be included in the proposal.
- 4. All authorities involved in the production of the proposal must accept that they have verified the figures and accept equal responsibility for their calculation. Each authority must also explain how the pooling arrangement would help achieve Best Value. Letters of acceptance from each authority involved must be submitted with the proposal.
- 5. Pooling arrangements must *improve* upon the overall level of recycling and composting *in terms of tonnage* compared with that which would have been achieved without pooling. Proposals must show the overall projected tonnages for the pool all household waste *and* recycled material based on existing Standards; then show how much tonnage of recycled material each authority will contribute to the pool according to the new arrangement; then convert that tonnage figure back into a percentage figure for each authority in the pool. This will account for the differing sizes of participating authorities, but maintain the principle of Standards set in *percentage* terms. Tonnages should be given to the nearest tonne and percentages to two decimal places.

All proposals should show how the relevant waste disposal authority's (WDA) overall tonnages are split down into waste arising from constituent collection authorities and from Civic Amenity sites if applicable, so the overall picture is clear.

FOR EACH AUTHORITY in the pool AND for authorities which might be affected by the pooling arrangement (i.e. where a WDA's standards are in part derived from constituent collection authorities'), calculate and/or set out:

- a) household waste arisings tonnage figures for each year from 2002-03 to 2007-08 using projections for future tonnage
- b) the existing Statutory Performance Standards for 2007-08

- c) the recycling and composting requirements in tonnage that the existing Statutory Performance Standards (i.e. without pooling) would place on that authority for 2007-08
- d) the recycling and composting requirements in tonnage that the new pooling arrangements will place on that authority for 2007-08
- e) the new percentage Statutory Performance Standards proposed 2007-08 [i.e. (d) divided by (a) x 100].

Check: Will the overall tonnage recycled in the pool be greater than the tonnage which would have been recycled if the standards had not been changed? Please also set out totals to demonstrate this check.

6. Local Public Service Agreements/Local Area Agreements:

Authorities with Local Public Service Agreement targets relating to recycling or composting of waste can get involved in pooling arrangements. Pooling arrangements will not amend these targets.

In terms of the pooling equation, authorities with stretch targets should not include the extra tonnage required by their "stretch target" as part of their existing requirements under 5(c) above. They should simply include the tonnage resulting from their existing Statutory Performance Standard. If any authority in the pool has agreed a stretch target for recycling and composting, it must set out the relevant details.

What is the deadline and where should we send our proposal?

Authorities wishing to pool their Statutory Performance Standards for 2007-08 should submit their full proposals by 20 October 2006 although we would encourage authorities to submit them earlier if possible, to:
