Summary of Progress Against Targets in Warwickshire's Municipal Waste Management Strategy

Report of the Strategic Director for Environment and Economy on behalf of the Officers Group

Summary

The report summarises the progress made by the Warwickshire Waste Partnership towards reaching the targets agreed in Warwickshire's Municipal Waste Management Strategy.

Recommendation

That:-

- 1. The draft report is approved (subject to any amendments necessary).
- 2. The report is made available on the Warwickshire Waste Partnership webpages.

1. Background

- 1.1 Warwickshire's Municipal Waste Management Strategy was adopted by the Warwickshire Waste Partnership in October 2005 and officially launched by the Partnership in January 2006.
- 1.2 It was agreed that the Partnership would publish an annual report highlighting progress against the targets agreed in the Strategy (the targets and objectives were detailed in the full version of the Strategy in Section 10).

2. Key Objectives and Reporting

- 2.1 Seven key target areas were identified in the Strategy, these are as follows:-
 - (i) To reduce the amount of waste produced in Warwickshire.
 - (ii) To develop integrated, sustainable solutions for managing waste in Warwickshire.



- (iii) To meet landfill diversion targets established by the Waste Emissions Trading Act (2003) – Diversion of biodegradable municipal waste.
- (iv) To meet and exceed statutory recycling and composting targets.
- (v) To work in partnership with each other and other stakeholders to implement the Strategy.
- (vi) To encourage public participation in the implementation and review of the Strategy.
- (vii) To regularly review and update the Strategy and Implementation programme.
- 2.2 A short report has been drafted which summarises progress against the targets (refer to **Appendix A**). The report also provides a brief summary of the general progress being made towards implementing aspects of the Waste Strategy.
- 2.3 Once agreed by the Partnership, it is intended to make the progress report available on the Warwickshire Waste Partnership's webpages.

3. Financial Implications

3.1 Failure to successfully implement Warwickshire's Municipal Waste Management Strategy could result in Warwickshire County Council failing to meet its landfill diversion targets and consequently being fined by the Government.

1 Introduction

1.1 Progress against targets in Warwickshire's Municipal Waste Management Strategy – Review year 2007/08

Warwickshire's Municipal Waste Management Strategy was adopted by the Warwickshire Waste Partnership in October 2005 and launched in January 2006.

By adopting the Waste Strategy, the Warwickshire authorities have agreed to work towards a number of quantifiable objectives which were identified in the Strategy.

It was agreed that progress towards achieving our targets would be reviewed and reported on an annual basis. This is the second annual report to provide a summary of our progress against our targets and progress with the implementation of the Waste Strategy.

The key objectives agreed in the Strategy were:

- To reduce the amount of waste generated in Warwickshire
- To develop integrated, sustainable solutions for managing waste in Warwickshire
- To meet landfill diversion targets established by the WET Act 2003 (diversion of Biodegradable Municipal Waste)
- To meet and exceed statutory recycling and composting targets
- To work in partnership with each other and other stakeholders to produce and implement the Strategy.
- To encourage public participation in the implementation and review of the Waste Strategy
- To regularly review and update the Strategy and implementation programme



2 Progress against key objectives, actions and indicators

Warwickshire's Municipal Waste Management Strategy established a number of key targets and objectives that the members of the Warwickshire Waste Partnership agreed to work towards. The following tables provide a list of our targets and objectives and summarise our performance against the targets. Where appropriate, 2007/08 waste data¹ has been used.

2.1 To reduce the amount of waste produced in Warwickshire

Waste prevention and reuse is critical to the development of sustainable waste management practices and was highlighted as one of the key objectives in Waste Strategy for England 2007. Greater focus on waste prevention will be recognised through a new national target to reduce the amount of household waste not re-used, recycled or composted.

The target in Waste Strategy for England 2007 is:

 Reduce the amount of household waste not re-used, recycled or composted by 29% by 2010, and 45% by 2020 – based on 2000 baseline figures.

2.2 To develop integrated, sustainable solutions for managing waste in Warwickshire

Positive progress has been made against these targets with a reduction in the amount of waste being landfilled and an increase in the amount of material recycled and composted.

2.3 To meet landfill diversion targets established by the WET Act 2003 (diversion of Biodegradable Municipal Waste (BMW).

Based on current predictions, Warwickshire will meet it's target in 2010 but will slightly exceed it in 2013.

Warwickshire has identified a need to obtain interim residual waste treatment capacity to contribute to meeting its LATs targets until the long-term residual waste treatment facility is operational. In support of this approach Warwickshire will be going out to tender later this year for a short-term residual waste contact. Warwickshire will also need to retain landfill capacity to dispose of waste that cannot be treated by any other means or rejects from other processes.

WCC will re-tender for its residual waste contracts in 2008/09. In the year 2007/08, 114,134 tonnes of Warwickshire's biodegradable municipal waste was landfilled, which is 80,725 tonnes less than our annual
		allocated allowance of 194,859 tonnes of BMW for the year.



2.4 To meet and exceed statutory recycling and composting targets

All of the Warwickshire authorities met their interim composting and recycling targets for 2006/07. The revised Waste Strategy for England 2007 has set a recycling and composting target of at least 40% for 2010.

The Warwickshire Waste Partnership is continuing to promote and support home composting. Warwickshire now has over 40 Master Composters, trained by Garden Organic. Volunteers who completed 30 hours of volunteering graduated to become full Master Composters in June 2008.

2.5 Work in partnership with each other and other stakeholders to produce and implement the Strategy.

Work on how to develop and strengthen the Warwickshire Waste Partnership is ongoing.

Following a report taken to Cabinet in October 2007 it was agreed that WCC should work in partnership with neighbouring authorities to develop shared solutions for the diversion of residual waste from landfill. Warwickshire County Council is actively working on two projects with neighbouring authorities.

A separate website for Project Transform has been developed to assist with the distribution of information relating to the project and provide accurate answers to some of the issues raised.

2.7 Regularly review and update the Strategy and implementation programme

To provide external assurance to the Waste Strategy Implementation (WSI) programme a Gateway review was carried out in June 2007. The review was carried out by the 4Ps who are impartial, external assessors.

The first review of Warwickshire's Municipal Waste Management Strategy will take place in 2008/09. The review will ensure that Warwickshire's Strategy incorporates the main objectives and targets from Waste Strategy for England 2007.

3 Progress with the Implementation of Warwickshire's Municipal Waste Management Strategy

Warwickshire's Municipal Waste Management Strategy sets out how the Warwickshire authorities plan to reduce the amount of waste sent to landfill while reducing the amount of waste generated and increasing recycling and composting. Warwickshire County Council is overseeing the project to put in place the necessary waste treatment infrastructure required to implement the waste strategy.

3.1 Waste Treatment Infrastructure

There are a number of project teams which are working on different aspects of the strategy implementation. Members of project teams include both district and county council officers. In some instances consultants have been appointed to provide specialist technical support and advice.

3.1.1 Biowaste

A contract was awarded to Biffa Waste Services in November 2007 for the treatment and diversion of biowaste from landfill following a competitive tendering process. The procurement was supported by Enviros. Biffa Waste Services has submitted a planning application for the development of an invessel composting facility to treat the biowaste and a Materials Recovery Facility (MRF) at its site at Ufton. The application was approved at Regulatory Committee on 22/07/08. Work to progress the development of a facility to serve the north of the County is underway with the first team meeting held in August.

3.1.2 Project Transform

Project Transform is a partnership of WCC, Coventry City Council and Solihull Metropolitan Borough Council. An Expression of Interest (EOI) was submitted to DEFRA for PFI credits in March 2008. Submitting the EOI was the first step in determining a funding route and treatment technology. The next stage is to submit an Outline Business Case (OBC) for the project. The deadline for submitting the OBC is 31st October 2008. WCC will know if the OBC has been successful by February 2009.

3.1.3 Waste to Resources (W2R)

Staffordshire County Council are proposing to build an Energy from Waste (EfW) facility at the Four Ashes Industrial estate in south Staffordshire. SCC approached WCC in the summer of 2007, to identify whether WCC would be interested in using this facility. After a full options appraisal it was decided that WCC would participate in the project. SCC submitted an OBC for their project to Defra in March 2008 and were recently awarded £122.4 million PFI credits. SCC intend to develop a 300,000 tonne Energy from Waste facility at the site. WCC will send 40,000 tonnes of waste to the facility from North Warwickshire and Nuneaton & Bedworth.



3.2 Gateway Review

In order to provide external assurance to the Waste Strategy Implementation (WSI) project, a gateway review was carried out in June 2007. The review took place over three days and was facilitated by the 4Ps, an organisation that was set up specifically to aid local government in delivering complex projects. The aim of the review was to provide a candid assessment of the project and its management by impartial, external assessors.

The review team gathered information by assessing documents relating to the project and also by interviewing 21 key stakeholders with a direct involvement or interest in the WSI project. On the final day of the review the report was presented to the Project Executive. The review team used a traffic light system (red, amber, green) to identify where the project was progressing well and also where improvement was needed.

Overall the gateway review process was a very positive process. The recommendations made will be taken forward where appropriate in order to improve the overall implementation of this project.

3.3 Waste Collection

The five district councils are leading on enhancing kerbside collection services for recyclable materials and have made significant investments and improvements to their collection schemes this year.

Warwick District Council started a new refuse and recycling collection scheme on 31/03/08. Different materials are collected on alternate weeks, with biowaste (green and kitchen) and dry recyclables one week and residual (nonrecyclable) waste the next. The scheme has proved successful in the first three months of operation achieving a provisional recycling rate of 60% with a minimal amount of waste going to landfill.

Stratford District Council's new collection service commenced on 4th August 2008. They have moved from sorting recyclable materials at the kerbside to a co-mingled collection (including glass, card, cartons, and plastic bottles) using a 240 litre wheeled bin. Stratford District Council will take mixed dry recyclables, to Green Star via a transfer station at Ettington until the Pure Recycling MRF at Ettington opens. Wheeled bins will also be provided for the collection of residual waste.

Nuneaton and Bedworth Borough Council have expanded the range of materials collected each week at the kerbside. The material collected now includes cardboard and mixed plastic (bottles and food containers). The dry recyclables are collected in a series of different coloured bags – blue for paper, white for textiles, yellow for cardboard, orange for plastics and a red box for all other recyclables, car batteries, engine oil etc.



North Warwickshire Borough Council have introduced a recycling scheme to service flats and isolated properties. Cardboard and plastic recycling banks have also been provided at two sites in Coleshill.

Rugby Borough Council has expanded the red box kerbside recycling scheme to a further 2000 properties, the scheme now covers 99% of the Borough. The green waste collections service has been expanded to a further 12,000 households, all properties that can accommodate green bins within the borough are now covered. Mini recycling centres are provided at all flats and sheltered housing complexes. Rugby Borough Councillors approved a proposal on 22nd July 2008, to implement a three bins service. The new collection service will collect dry recycling: consisting of paper, glass, cans, cartons and plastics, organic waste such as garden and kitchen waste, and residual waste. The system will see the three bins emptied over a two week collected with the green (organic) bin for composting; residents will have the option of a weekly collection of food waste, by placing it in either the residual waste bin or the green (organic) bin.

3.4 Household Waste Recycling Centre Improvements

Warwickshire County Council's plans to upgrade and redevelop the household waste recycling centres are now well underway.

Hunters Lane household waste recycling centre (HWRC) in Rugby was closed from September 2007 to March 2008 for a £1.8 million refurbishment. The newly refurbished HWRC offers improved facilities for the residents of Rugby and has been specifically designed to ensure the site can meet the current and future recycling needs. The Hunters Lane site was rebuilt using nearly 7,500 tonnes of recyclable material. The use of recyclable materials on site not only saved a considerable amount of valuable material from being sent to landfill, but also reduced the overall amount of raw materials needed to develop the new HWRC.

Warwickshire County Council is working with neighbouring Staffordshire County Council to develop a new HWRC and waste transfer station at Lower House Farm. The new facility will replace the existing HWRC at Grendon. Warwickshire County Council purchased the site subject to obtaining planning permission. Consultants ARUP have been engaged to support the development of the project. A pre-planning consultation event took place on in July and a planning application was submitted in August 2008. Warwickshire and Staffordshire County Councils will jointly finance the development and operation of the facilities. The HWRC will be for the use of both North Warwickshire's and Tamworth's residents. There are also plans to include a transfer station on the site to transfer waste arising in North Warwickshire, Tamworth and parts of Nuneaton to a proposed energy from waste plant in south Staffordshire.

Minor improvement works such as resurfacing were carried out at Stockton and Cherry Orchard HWRC's in 2007.



4 Progress with 2007 Next Steps

- Update the dedicated webpages on the work of the Warwickshire Waste Partnership (WWP) and progress with the implementation of Warwickshire's Municipal Waste Management Strategy.
