# Overview of Warwickshire Waste Partnership achievements and upcoming work streams

#### 1.0 Introduction

1.1 This report introduces the presentation highlighting the achievements of the Warwickshire Waste Partnership and gives an overview of the upcoming work programme.

#### 2.0 Achievements of the Partnership

2.1 A full overview of the achievements of the Partnership over the last 10 years will be provided in a presentation.

## 3.0 Modelling work

- 3.1 A workshop was arranged for the December 2016 waste partnership meeting to explore the following theme:
  - "What are the opportunities for our Partnership to achieve our targets and make the necessary saving each of us need to make"
- 3.2 Overall, the discussions throughout the workshop suggested that there was a strong desire to work together across the Partnership, and to review services and arrangements across and between the two tiers to deliver greater efficiencies to the tax payer.
- 3.3 Following on from the workshop the County agreed to pay for the following initial modelling work:
  - Modelling of current kerbside collection system, data gathering and asset mapping, including modelling the baseline collection system for five Warwickshire authorities, the capacity and locations of depots and tipping points and compiling comparative data of current service performance



- Options appraisal scenario modelling kerbside collection systems including scenario modelling of potential collection systems for five Warwickshire authorities and review of potential single client efficiencies
- 3.4 The first phase of the modelling is completed and it is expected that the options appraisal scenario will be completed soon.
- 3.5 The partnership will be kept up to date with the work stream.

### 4.0 Behaviour change

- 4.1 An overview of the planned behaviour change projects for 2017/18 is provided below:
  - Food waste recycling project in Stratford District
  - HWRC trade waste promotion
  - Crackdown on HWRC trade use and unsorted waste going to landfill, including renewed signage
  - Waste composition analysis
  - In to Win
  - Home composting bin sales, workshops, video and PR
  - Food waste caddy liners
  - Slim you Bin
  - Waste minimisation and recycling promotion in schools including 'wastebuster'
  - Waste minimisation promotion including Love Food Hate Waste, junk mail, real nappies, seasonal campaigns and re-use
  - Events for District and Borough staff
  - Flytipping prevention
- 4.2 Warwickshire County Councils planned behaviour change programme of work to be undertaken in 2017/18, along with planned timescales for each project component is provided in Appendix 1.
