		Fine to redo programme from September, but the current proposals force schools to stop delivering All About Me straight away even though the review is generally positive about the programme and doesn't raise any red flags about possible harm. Existing schools using AAM not needing county support (possibly in the 100s) should be allowed to deliver programme up to the end of the summer term if they wish.

Council Investment Funds – Criteria	Councillor Chilvers:
for the Allocation of Resources	Given the large amount of money involved in these funds and the impact on delivery of key council objectives member oversight is important. Could the following changes be made to the process?
	i) Members be sent a list of bids that make it to stage 2. (only hearing about them when they make it to cabinet is too late).
	<ul> <li>ii) A member who is an observer sits in on presentation of bids at stage 2. For instance, each O&amp;S could be allocated one of the funds and one of their number be present and feedback (in private session if nec) to the committee.</li> <li>Could similar changes be made to the CIF fund also discussed in this report?</li> </ul>
	50% of the criteria is on 'deliverability' and one bullet point is on 'return on investment'. Please could you clarify whether this is specifically about cashable savings (i.e. money that the organisation will directly save) or wider savings to the Warwickshire community (i.e. an anti-flooding scheme may be very effective for the cost, but won't necessarily save the organisation money)?
	Lots of projects need a mixture of revenue (esp. officer time) and capital, but yet this doesn't seem to be reflected in these processes. How can this be addressed to prevent bids having to be put through two processes causing unnecessary delay?

All About Me is being stopped straight away which seems to go counter against the review findings. I agree with Jonathan that Schools using AAM not needing county support should be allowed to deliver programme up to the end of the summer term if they wish. The Comms message around this was what went wrong.
2	Service Estimates 2020/21	No real comments except the outcome from this pandemic will play into budgets and departments may need flexibility to operate.
3	Council Investment Funds – Criteria for the Allocation of Resources	I would like to see greater clarity around allocation and process. Perhaps it should be considered going forward that greater investment into the third sector to support their work during this time and that all future funding should be frozen to allow a redirection to support communities.
4	Early Intervention, Prevention and Community Capacity Fund2019/20 - Tranche 4 Allocations	No problem but has taken some time to get here links to number 3.
5	New Highway Safety Inspection Manual	Yes, looks OK would also confirm Councillor Chilvers' point re cycle ways.
