#### 1. Decision taken

That the Portfolio Holder for Education and Learning agrees to go to public consultation on proposals to change the SEN Home to School Transport Service & Policy as provided for in the Appendices to this Report.

#### 2. Reasons for decisions

- 2.1 As part of the SEND & Inclusion Change Programme, Council officers have been reviewing current arrangements for SEND Home to School Transport. This included an external review.
- 2.2 The SEND Home to School Transport Service is seeing an increase in demand year on year. In addition, costs are increasingly significantly driven by inflationary pressures on transport operators.
- 2.3 A number of changes to internal processes were recommended as part of the review which are being implemented. Three items are proposed for public consultation as two items make changes to the process for a vulnerable group (children with SEND) and the final item is to clarify the Council policy.

#### 3. Background information

- 3.1 As part of the SEND & Inclusion Change Programme the current arrangements for SEND Home to School Transport have been reviewed. A series of changes are taking place through the implementation project. Three areas of change are proposed for public consultation:
  - i. A new Needs Assessment Matrix Framework
  - ii. A simplified application process
  - iii. Clarifications to the transport policy
- 3.2 A new Needs Assessment Matrix Framework (NAMF). The process in analysing potential options for transport is based on Risk Assessors knowledge within transport and SEND. A tool

is proposed to better aide potential transport options for young people based on their need and ensure consistency of decision-making. Based on the child's needs the tool would identify the appropriate mode of transport (eg. bus, multi-person taxi) and other viable options to be offered (eg. direct travel payments). The tool would also identify if a young person should be considered for independent travel training. The introduction of this tool would help standardise travel options based on needs and ability but also make the decision-making process more efficient.

- 3.3 **Simplified Application Process.** The transport service needs to better manage the demand coming into the service. Currently the process does not allow this as applications come in June August ready for September. Having such a short timescale means the team cannot review the application, eligibility, need and options sufficiently resulting in increased use of single taxis to going to the same settings.
- 3.4 The new proposed process would remove the need for parents and carers to apply or choose their home to school transport options. Instead, the Special Education Needs transport team would complete the assessments and present the options at a set time in the academic year, following school placements being confirmed in the issuing or update of the EHC plan (by the SENDAR team). This would allow for better management of the demand coming into the service as the process will begin much earlier on in the year. This would contribute to the reduction of the SEND Home to School Transport overspend, increase alignment to preparation for adulthood and provide more efficient processes.
- 3.5 Clarifications to the transport policy. It is proposed to clarify the Home to School and College Transport Policy to allow a clear understanding for both Parents/Carers, schools and settings, and Transport internally. In particular, clarity is required on the deployment of passenger assistants (to be subject to a risk assessment) and post 19 policy and implementation.
- 3.6 Council officers are seeking permission to consult on the proposed changes to the SEND Home to School Transport service and policy identified above. Appendix A sets out the Public Consultation Document on the SEND Home to School Transport Service and Appendix B sets out the questions to be asked in the consultation.
- 3.7 The consultation is proposed to run 3<sup>rd</sup> December 2022 to 26<sup>th</sup> February 2023 and would run separately, but concurrently with, the consultation on the SEN Service Review.
- 3.8 The consultation will engage with the public and key stakeholders in a number of ways:
  - a) Information and an online questionnaire will be publicly available on Warwickshire County Council's consultation and engagement hub
  - b) Drop-in sessions will be held in educational settings
  - c) Meetings will be held with key stakeholders
- 3.9 It is proposed that final proposals will be presented to Cabinet for decision on 26<sup>th</sup> April 2023 with implementation by 1<sup>st</sup> September 2023.

#### 1. Decision taken

That the Portfolio Holder for Education and Learning agrees to commence public consultation on proposals for changes to the service offer of WCC SEND and Inclusion Services, as provided for in the Appendices to this report.

#### 2. Reasons for decisions

- 2.1 The SEND & Inclusion Change Programme included a project titled 'Service Reviews' to review each County Council SEND & Inclusion team to ensure the local offer was value for money and supporting the objectives already of the change programme. External reviews of services identified statutory responsibilities and where improvements could be made to the service offer.
- 2.2 The Council has also taken external advice on whether any changes to the Service Offer require public consultation. The Council is also mindful that in the SEND Local Area Inspection in 2021, one of the areas for improvement was to improve 'the fractured relationships with parents and carers and lack of clear communication and co-production at a strategic level'. It is therefore considered that as best practice, a public consultation on the Service Offer is advisable.
- 2.3 To be clear, the Council must consult if elements of the current Service Offer are being withdrawn but no activities are proposed for withdrawal. Therefore a public consultation is not mandatory.
- 2.4 In providing clarity on the local SEND & Inclusion Service Offer, the Council will achieve the following objectives:
  - Have a service offer consistent with putting the child and family at the centre of our services (Children and Families Strategy)

- Provide a contribution to the 'graduated response' from schools and settings to deliver early intervention for children without EHC plans to build capacity
- Ensure the best outcomes are achieved from allocated resources
- Ensure services operate across all ages 0-25
- 2.5 In addition, it considered that transparency from this process will contribute to building confidence with parents and carers of children with SEND.

#### 3. Background information

- 3.1 The proposals are set out in Appendix A (Draft Public Consultation Document). The proposal to the Portfolio Holder is that the Council goes out to public consultation on the Service Offer for SEND & Inclusion. This Service Offer is made up of:
  - The statutory offer (not up for consultation)
  - The core offer (new and existing activities proposed for comment through public consultation)
  - The traded offer (existing activities proposed for comment through public consultation)
- 3.2 No activities currently offered by the Council are to be withdrawn.
- 3.3 The consultation would propose new activity in a core offer including the following areas:
  - An allocation of paid-for Educational Psychologist time for schools (currently fully traded to schools)
  - The introduction of annual conversations and SEND audits to improve planning and evaluation of SEND in Warwickshire schools
  - An annual paid-for training offer to schools
  - Increasing the offer of support services up to the age of 25
- 3.4 In providing this support, paid-for by the Council, it is considered that schools would be able to identify and support SEND at an earlier stage as part of a graduated response.
- 3.5 These proposals would be resourced through appointing to current vacancies that have been carried for a number of years and future restructure to services.
- 3.6 The percentage of children with special educational needs and disabilities (SEND) continues to increase. The percentage of children identified with SEND at SEN Support (non-statutory level) has increased from 11.4% in 2017 to 12.9% in 2022 at school age. The percentage with EHC plans (statutory support) has risen from 3.1% to 3.8% over the same period. This reflects national trends.
- 3.7 In response to this increased demand for support, Council officers consider it is appropriate that the Council reviews its own Service Offer and refines it as appropriate.

- 3.8 Based on those reviews, the service managers reflected on what the offer of SEND & Inclusion Services should be and how this should be delivered. A common theme from the reviews, consistent with the Impower report previously, was the importance of a non-statutory offer to ensure that children with special educational needs are identified and supported early. Ofsted also highlighted in the SEND Local Area Inspection the need for schools to be more inclusive, and the pilot inspection from Ofsted highlighted that children at SEN Support (non-statutory support) was an area for improvement.
- 3.9 The reviews also commented on how services worked together (or not) and how they understood their own offer of services.
- 3.10 A period of engagement with staff and stakeholders then took place over the summer term on clarifying the what the SEND & Inclusion Service Offer is. This is made up of the statutory offer, the core (non-statutory) offer and the traded offer. The service also engaged on how it could deliver such a Service Offer more efficiently. Engagement has taken place with staff, school leaders, parent carer forum, young people's forum and hard to reach groups.
- 3.11 In clarifying and developing a 'core offer' (separate to the statutory and traded offer) the service has then tested the affordability of all proposed activities.
- 3.12 The service is now ready to propose a new Service Offer.
- 3.13 Appendix A sets out the Public Consultation Document on the SEND & Inclusion Service Offer. Appendix B sets out the questions to be asked in the consultation.
- 3.14 The consultation is proposed to run 3<sup>rd</sup> December 2022 to 26<sup>th</sup> February 2023 and would run separately, but concurrently with, the consultation on SEN transport.
- 3.15 The consultation will engage with the public and key stakeholders in a number of ways:
  - a. Information and an online questionnaire will be publicly available on Warwickshire County Council's consultation and engagement hub
  - b. Drop-in sessions will be held in educational settings

#### 1. Decision taken

The Portfolio Holder approves the commencement of a 6 week consultation on Admission Arrangements, Co-ordinated Scheme and In Year process for school admissions for the 2024/2025 Academic year

#### 2. Reasons for decisions

- 2.1 Under the school Admission Code 2021 when changes are proposed to admission arrangements, all admission authorities must consult on their admission arrangements that will apply for admission applications the following school year.
- 2.2 Minor changes are proposed for the 2024/2025 Admission Arrangements concerning decreasing the published admission number (PAN) at four Warwickshire maintained schools to bring the PAN in line with the class organisation of those individual schools.
- 2.3 Clarification is required to the in year application process to better reflect operational changes within the admissions process.

#### 3. Background information

3.1 The changes proposed reflect the current class organisation at Long Lawford Primary and Exhall Junior School to support those schools' long term finiancial planning along with a change at Brownsover Infant School support the existing approval by Cabinet in July 2022 to reorganise to a primary school, details are given below.

#### 3.2 Long Lawford Primary school

Proposal to change PAN from 90 to 60

It is proposed to reduce the published admission number (PAN) from 90 to 60, subject to consultation.

Pupil forecast data suggests that while pupil numbers in the Rugby area are expected increase for key stage 2 and in secondary schools there is expected to be surplus places in reception and KS1. There have been low intakes at Long Lawford Primary School over the past few years due to parental preference in an area where surplus places are usually available in alternative schools in neighbouring planning areas. Currently both reception and year 1 have less than 60 children on roll and operate with two classes in each year group.

However, as the current PAN is 90 should either year group reach 61 children the school would be required to employ an additional teacher and operate as three smaller classes to comply with infant class size legislation, which places a maximum number of 30 children per teacher.

This change seeks to assist the school to plan for long-term stability, a consistent structure, and a sustainable financial position. Governors are concerned that operating three classes in Reception with low pupil numbers will be financially unsustainable, reducing the PAN to 60 provides greater certainty that only two classes will be required, allowing for better financial stability.

As there is no proposed reduction in the physical capacity of the school buildings the option remains for the school to increase PAN again in the future should pupil numbers increase in the local area.

#### 3.3 Exhall Junior School

Proposal to change PAN from 60 to 45

It is proposed to reduce the published admission number (PAN) from 60 to 45, subject to consultation.

Pupil forecast data suggests that while pupil numbers in the Rugby area are expected increase for key stage 2 and in secondary schools there is expected to be surplus places in reception and KS1.

There have been low intakes at Exhall Junior School over the past few years due to parental preference in an area where surplus places are usually available in alternative schools in the area. The low intakes are mirrored in the partner infant school, Exhall cedars Infant School, which has less than 45 children on roll in each year group. Exhall Cedars infant is the direct feeder into Exhall Junior School, there are no other Infant and junior schools in the immediate local area. This change seeks to assist the school to plan for long-term stability, a consistent structure, and a sustainable financial position.

The school has confirmed they are currently organised into a Lower KS2 phase and Upper KS2 phase, consisting of six classes. There are three classes in each phase:

Lower KS2 – has three classes with mixed Year 3 and Year 4 children Upper KS2 – has three classes with mixed Year 5 and Year 6 children

Formal reduction of the PAN to 45 will support this organisation to continue long term reducing the overall number of classes and teachers that will be required

perminantly, allowing for better financial stability.

As there is no proposed reduction in the physical capacity of the school buildings the option remains for the school to increase PAN again in the future should pupil numbers increase in the local area.

#### 3.4 Brownsover Infant School

Proposal to change PAN from 60 to 30

In July 2022 Cabinet approved the change of age range at Brownsover Community Infant School from age 3 to 7 to age 3 to 11 with effect from September 2026, to allow the school to convert from an infant school to a primary school. Consultation was previously undertaken on this change of age range ahead of the July 2022 cabinet approval. As part of this change the school's intake will be reduced from 60 to 30.

Capital funding as also approved in July 2022 to support three of the existing infant class bases being converted to accommodate KS2 children, and one further class base being delivered as part of the capital project to provide appropriate accommodation for a 210 place primary school.

In order to ensure only one class, or 1fe, of children transfer to year 3 in September 2026, when the school formally becomes a 1fe primary school, a reduction in the reception intake has been agreed by the school adjudicator for September 2023. This approval by the school adjudicator is for the intake of September 2023 only and therefore consultation is required to perminantly reduce the school's intake from 60 to 30 to enable the conversion from 2fe infant school to 1fe primary school.

3.5 Senior leaders and governing bodies at all schools concerned are aware of and support the proposed changes.
