### Schools Block Funding 2024-25

This report relates to mainstream academies and maintained schools and voting on this item is limited to schools members, academies members and PVI representatives.

### **Recommendations**

Schools Forum members are asked to agree:

a) The transfer of 0.5% of Schools Block funding to the High Needs Block for 2024-25

If the Schools Forum do not agree this recommendation, then the Schools Forum members are asked to consider the following:

b) The transfer of 0.25% of funding from the School Block to the High Needs Block in 2024-25 or an amount between 0% and 0.5%.

### 1. Purpose

- 1.1 Within the Dedicated Schools Grant, the ESFA allow for Schools Forum to move up to 0.5% between the blocks. This proposal is to move 0.5% from the Schools Block to the High Needs Block (at a value of approximately £2.255m) to address part of the financial pressures within the High Needs Block resulting from the forecast High Needs Block overspend in 2024-25. It should be noted that High Needs Block and SEND financial pressures are a national issue, with Local Authorities lobbying that there is insufficient funding from Central Government.
- 1.2 A consultation has taken place with schools between Friday 15th September 2023 and Monday 6th November 2023.
- 1.3 The full consultation document is attached as Appendix A.
- 1.4 The Local Authority may make a disapplication to the Secretary of State to move 0.5% of funding, should Schools Forum not agree the move. The deadline for submitting this disapplication this year is 17th November 2023. If the Schools Forum do not agree to a transfer, please note that the Council are considering the submission of a disapplication due to the wider financial implications on the Local Authority.

1.5 It should also be noted that these proposals will only impact the 2024-25 schools budget allocations, and not future years.

### 2. Background

- 2.1 When the National Funding Formula (NFF) was introduced in 2018-19 the Local Authority with Schools Forum agreement indicated that they wanted to replicate the 'hard' NFF as quickly as possible, subject to affordability. This was achieved in 2020-21 for the first time due to an increase in grant.
- 2.2 Following consultation, Schools Forum agreed to move 0.5% of the Schools Block to High Needs Block for 2022-23.
- 2.3 Modelling for the consultation for 2024-25 (dated September2023) was based on the indicative Schools Block allocation provided by the DfE before recent retraction by the DfE. The modelling in this report is based on the revised indicative Schools Block allocation provided by the DfE and is still subject to change. The current modelling is based on the October 2022 census data. Final budgets will be updated for the October 2023 census, this is usually published mid to end December 2023.
- 2.4 The monetary value of the 0.5% transfer is calculated by taking the total schools block funding for DSG, then adding the premises funding and growth funding. It is estimated that this will equate to approximately £2.255 million.
- 2.5 The Schools Forum is aware that the Local Authority has established a SEND and Inclusion Change Programme to address the financial pressures in the High Needs Block and has provided regular updates on the progress of the programme. Achievements set out in the consultation document include:
  - a) The overspend of the High Needs Block has significantly reduced against the original forecast.
  - b) More children and young people with SEND are being supported in mainstream settings.
  - c) The number of children attending specialist resourced provision is increasing.
  - d) More children are supported in state-funded specialist settings, including the opening of a new special school.
  - e) The percentage of children and young people attending independent specialist provision (ISP) has reduced.
  - f) The number of EHC plans in pre-school years is increasing.
  - g) A new method for calculating top-up funding for children with EHC plans has been agreed and is being rolled-out.
- 2.6 Schools Forum is asked to note that the total level of school balances (reserves) at 31st March 2023 for maintained was £18.3m and 31st August 2022 for academies was £42m.



2.7 The modelled proposals have a direct impact on the indicative school budgets. The latest data at Appendix C suggests that 185 of 231 schools would be impacted and the impacting range will be from £1,032 to £68,817 and **0.22% and 0.75%** change to the initial indicative budget. Schools which trigger the Minimum Funding Guarantee are protected so that there is no change to their individual school budget.

### 3. Consultation Outcomes

3.1 Section 6.1 of the High Needs Funding 2023-24 Operational Guide states: Transfers between blocks can be made from the high needs and the central school services blocks. Movement from the early years block can be made in compliance with the early years pass through rate conditions, details of which can be found in the <u>early years entitlements</u>: <u>local authority funding of providers operational guide</u>. The schools forum must be consulted on all transfers between blocks. The schools block is ringfenced which means that this block must be spent for the purposes specified in the conditions of grant. Local authorities retain the ability to transfer up to 0.5% of funding out of the schools block, with the agreement of the schools forum.

Formal permission from the Secretary of State (a disapplication of the DSG conditions of grant) will be required for transfers out of the schools block above 0.5%, or any amount without schools forum approval. This applies to any transfers even if approval has been given in previous years. Local authorities should consult with local maintained schools and academies. The schools forum should take these views into account before making their decision.

- 3.2 Consultation was undertaken with all Warwickshire schools and academies from the primary and secondary phases.
- 3.3 A total of 38 academies and maintained schools responded to the consultation by the 5:00pm deadline on Monday 6<sup>th</sup> November 2023. This consisted of 30 primary schools and 8 secondary schools. Responses from federations or multi academy trusts have been disaggregated to reflect the number of schools within the federation or MAT (e.g. A MAT responding on behalf of 4 schools is counted as 4 responses).
- 3.4 The consultation posed three questions, each with a follow up question asking for any 'no' response.

3.5 In response to question 1: Do you agree that the Local Authority should propose to the Schools Forum a transfer of up to 0.50% from the Schools Block to the High Needs Block to support the High Needs budget in 2024-25, if sufficient funding is available without affecting the 'hard' NFF allocations to schools?

- 1. Any reference to schools in this document applies similarly to academies unless stated otherwise.
- 2. The elements of the Schools' funding formula are applied on the same basis to both maintained schools and academies. The difference is that maintained schools currently receive their funding from the Authority for the financial year April to March and academies have the same funding formula applied over the academic year September to August.

### **PURPOSE**

- Warwickshire is now fully convergent with the National Funding Formula (NFF) for Schools. Initial modelling of Schools Block funding for 2024-25 indicates that Warwickshire will be able to allocate the 'hard' NFF in full.
- 2. The purpose of this consultation document is to outline Warwickshire County Council's (the Authority) proposal to move up to 0.5% of funding from the Schools Block to the High Needs Block in 2024-25.
- 3. The outcome of the consultation will be reported back to Schools Forum on Thursday 16<sup>th</sup> November 2023. The consultation provides an opportunity for primary and secondary schools and academies to comment on the following proposal:
  - a. Moving up to 0.5% of funding from the school block to the High Needs Block in 2024-25;
- 4. Schools are asked to respond to this consultation by completing the Response Template. Responses should be submitted by 5pm on Friday 27 October 2023. Responses can be submitted through via the <u>Consultation Response Form</u>
- 5. Responses received will be analysed and shared Schools Forum at its meeting on Thursday 16 November 2023 prior to the Authority deciding on the final funding formula for use in 2024-25 to be submitted to the DfE mid-January 2024.

### NATIONAL FUNDING CONTEXT

- 6. The DfE has confirmed that the arrangements in 2024-25 will continue to allow some local discretion through what is termed a 'soft' funding formula. The soft formula means that the Authority can still decide how it allocates its funding to schools using the available NFF factors but has flexibility to determine the use and/or value of these factors. By contrast, when the DfE moves to a 'hard' formula, each school will receive its funding through the NFF directly from the Education and Skills Funding Agency (ESFA). In any event, WCC and Schools Forum have already approved moving to the Hard NFF.
- 7. The Dedicated Schools Grant (DSG) continues to be ring-fenced. There are four well established blocks as set out below. The Schools Block continues to be ring-fenced with one exception that the Authority can move up to 0.5% of the Schools Block to other Blocks after consultation with schools and after approval by the Schools Forum.

### SCHOOLS' NATIONAL FUNDING FORMULA 2024-25 OVERVIEW

- 8. The factors used in the 2023-24 Warwickshire school funding formula (excluding the area cost adjustment) are set out in Table 1 alongside the factors in the 2024-25 NFF and the difference between them. As can be seen from the difference column, the rates for each of the factors have increased by at least 2% (subject to rounding) as a result of the Government's additional investment in schools funding. Warwickshire has implemented the NFF in terms of the factors and rates in 2021-22 and the intention is to mirror the factors and rates for 2022-23.
- 9. The funding arrangements for 2024-25 are as follows:
  - a) The mandatory Minimum Per Pupil Guarantee (MPPG) for primary and secondary pupils. For 2024-25 these are set at £4,655 for Primary and £6,050 for Secondary pupils.
  - b) The minimum funding guarantee (MFG) will be set at +0.50%.

### LOCAL CONTEXT: THE SEND & INCLUSION CHANGE PROGRAMME

- 10. In responding to this consultation, school Leaders should be aware of the SEND & Inclusion Change Programme. This was launched in October 2020.
- 11. In the following pages, we will outline what the programme has already achieved and seeks to achieve, what the financial situation is, and how the Council is seeking to work with schools to address the current situation.

### What are we hoping to achieve?

- 12. Our Vision for learners with Special Educational Needs & Disabilities (SEND) is that all our children and young people have the right to lead a fulfilling life and to be part of their community.
- 13. We want our learners with SEND to feel fully included in their local schools, wherever appropriate, by giving schools the resources and skills to meet their special educational needs.

### Why do we need to change?

- 14. We know that things need to change because outcomes for our children and young people with SEND have been getting worse and we are spending well above our allocated budget. The demand for services continues to rise due to local population growth and growing complexity of needs. Our system is not equipped to meet this growth sustainably.
- 15. Warwickshire supports 5,314 children and young people with EHC plans (census day in January 2023), an increase of 546 compared to the total number of EHC plans from the previous year. At school age, 3.9% of Warwickshire children have an EHC Plan. Whilst the increase in demand is in line with national trends, the data demonstrates the increased pressure on the system.
- 16. The Council identified pressures on the High Needs Block in 2020 and set up the SEND and Inclusion Change Programme in response. Through a combination of additional funding from Department from Education, moving allowable funds between Schools Block and High Needs Block and the impact of the SEND and Inclusion Change Programme, the forecast in-year deficit was significantly reduced in 2021/22 and 2022/23. However, forecasts for 2023/24 show an increased deficit once more, partly in response to growing demand.
- 17. Funding from the High Needs Block is primarily spent on support for individual learners' in schools and settings, as set out in their Education Health and Care plan

(EHCP). The placement of children matters from a financial perspective because, as a general rule, the more specialist an educational setting is, the higher the cost of provision. Whilst this must always be needs-led, census data shows where Warwickshire is an outlier compared to other areas. Warwickshire has less children with EHC plans in mainstream schools (34.4%) in comparison to statistic neighbours (39.6%, more children in special schools (30.4%) than our statistical neighbours (28.4%) and has a total of 5.5% of children and young people in independent specialist provision. In recent years, we have also seen an increase in the number of our children and young people in alternative provision with a total of 12.8% in 'other' settings Within Warwickshire, a lower percentage of 16–17-year-olds with SEND are Not in Education, Employment or Training (NEET), (4.7% with an EHC plan) compared to national average (6.9%) and statistical neighbours (6.7%).



### Outcomes

19. In 2021/22, our young people with SEND achieved higher Attainment 8 scores (14.7% with an EHC plan) by the end of the Key Stage 4 compared to national average (14.3%), although the scores of young people with EHC plans is lower than statistical neighbours (14.9%). More of our young people with SEND achieve a level 3 qualification at aged 19 (16% with an EHC plan) compared to national averages and statistical neighbours (both 14%).

### Financial sustainability

- 18. The current system is financially unsustainable. If we carry on as we are, there will be a £11m gap between our funding allocation and our expenditure by 2024/25. Whilst we continue to work through local government networks and associations to gain sustainable funding from central government, we must do everything we can to meet our statutory duties within our allocated resources.
- 19. The cumulative effect is an overspend of £37.944 million by 2024/25 if no interventions are made (total of the gap between DSG Position and DSG Allocation over that period). The graph below shows the gap between forecast allocations and expenditure, with and without the SEND & Inclusion Change Programme. Even with significant changes, it is anticipated that in order to deliver statutory duties there will be a gap between funding and expenditure.

- 20. The cost of a placement in Independent Specialist Provision (ISP) is almost three times as much as a placement in a mainstream school. Costs of alternative provision are also rising.
- 21. The more we can do to channel resources into early identification and intervention in our mainstream schools, the better outcomes we can achieve for our children and young people, and the more financially sustainable we will be. This will also allow us to use our state-funded specialist provision for our children and young people with the most complex needs.

### What has been achieved by the SEND & Inclusion Change programme?

22. At the SEND Local Area Inspection, Ofsted commented on the SEND & Inclusion Change Programme:

Area leaders understand the strengths and weaknesses of the area because of their accurate, well-informed and detailed self-evaluation. ...Leaders have developed and started to implement an ambitious Change Programme in response to the findings of the reviews.

The Change Programme identifies what needs to change and why. It has prioritised and focused on key areas, with further actions appropriately planned out in the right order. This is enabling area leaders to drive the necessary improvements across the local area.

Area leaders' rapid implementation of the Change Programme has already led to some improvements.

- 23. There is clear direction of travel on key factors affecting spend following the introduction of the SEND & Inclusion Change Programme:
  - i. The percentage of children and young people attending independent specialist provision (ISP) has reduced. Comparatively, Warwickshire now has 5.5% of children placed in ISP compared to 7.3% in 2020. However, with overall numbers of children with EHC plan rising, the number of children supported in ISP is also increasing.
  - ii. The number of children attending specialist resourced provision is increasing. Since 2020, 10 new resourced provisions have opened and some existing resourced provisions have expanded their number of places. The number of places has increased from 109 to 211. These provisions allow for specialist provision in mainstream settings delivering positive outcomes, value for money and freeing up places in specialist settings.

- iii. More children and young people with SEND are being supported in mainstream settings. There are 34.4% of children and young people attending mainstream schools in comparison to 29.7% in 2020.
- iv. More children are supported in state-funded specialist settings. This was expected due to population growth, increased complexity of need and less use of independent specialist provision (ISP). 1615 children are supported in state-funded specialist setting compared to 1486 in 2020. The Warwickshire Academy was opened in 2022 as a new special school for children with special, emotional and mental health needs. Capital spend for expanding provision at Evergreen and Oak Wood Schools has also been approved.
- v. **The growth in new EHC plans** initially reduced but has rose significantly to 11.5% in 2022-2023.
- vi. **Increased the number of children with EHC plans prior to Reception Year** with 181 children issued with EHC plans in September 2023, compared to 135 in September 2022.
- vii. A new top-up funding matrix has been developed to ensure mainstream and special school schools receive the right funding at the right time. This is being rolled out from September 2023.
- viii. **Completed an 'Inclusion Framework' trial** bringing schools together to improve their SEND practice and build confidence with parents.
- 24. In addition, the programme has introduced a new Quality Assurance Framework, issued new SEND & Inclusion Guidance and Transitions Guidance, reviewed Council services funded by the High Needs Block, redesigned the Local Offer and established a new Parent Carer Forum.

### What are you expecting to see in the next year?

25. In the coming year the change programme will:

- Roll-out the new top-up funding matrix
- Test the 'Inclusion Framework' with two further groups of schools
- Take forward the Emotionally Based School Avoidance project to help young people with SEND back into school
- Create an infrastructure to increase supported internships for young people with SEND post 16

### Is Warwickshire different to other local authority areas?

26. The pressures on the High Needs Block are not unique to Warwickshire. Warwickshire is one of 55 local authorities working with the Department for Education regarding improving outcomes and sustainable funding for children and young people with SEND in a scheme called Delivering Better Value.

27. The Delivering Better Value scheme is reviewing the current spend of the Council through a national standardised methodology and will be making further recommendations for change.

### **PROPOSED FUNDING CHANGES**

- 28. The Authority is planning to continue to implement the 'hard' NFF for all Warwickshire schools in 2024-25. Based on the indicative Schools Block allocation for 2023-24, the 'hard' NFF is affordable. However, to fund a transfer from the Schools Block to the High Needs Block, individual schools' budgets will be impacted.
- 29. A transfer from the Schools Block to the High Needs Block of 0.5% equates to £2.255m and a transfer of 0.25% equates to £1.127m.
- 30. Modelling on the indicative Schools Block allocation for 2024-25 establishes the following:

• The method to release up to a 0.5% transfer whilst still implementing the 'hard' NFF would be to amend all NFF factors (rather than only the Basic Entitlement factors or only the Additional Needs factors).

• Not all individual schools' budgets are impacted. Schools which trigger the Minimum Funding Guarantee (65 schools) are protected so that there is no change to their individual school budget.

• A full list of how schools' budgets will be impacted by either a 0.25% transfer or a 0.5% transfer can be found in Appendix A

31. Please note that the modelling is based on the indicative Schools Block allocation provided by the DfE, which is subject to change. It is based on **October 2022 census data**, which could change. This will not be known until mid to end December 2023.

### Reasons for 'Yes' responses:

Higher than ever levels of acutely needy pupils entering the mainstream school system means that high needs funding will be more appropriate than ever.

The SEND needs in school are increasing exponentially

Currently have high levels of SEN and EHCP

The increase in EHCP's and need across Warwickshire means further funding is needed.

Knowing how tight the high needs budget is, I believe it is fair for all schools to contribute towards this. However, all schools are also struggling and a 0.25% is a fair compromise.

The high needs block needs this financial support in order to continue provision.

We are seeing - since the pandemic - that we are presented with more SEND challenges with smaller school budgets. This is having a negative affect on our children with needs and the provision we can provide them. It is very difficult to ensure quality EDI across our provision when we are given less money to do so.

From a moral perspective I cannot see how anyone could object to this if it is NOT affecting the budget of their own school?

The high level of SEN pupils means that more budget is required.

Slippery slope argument - it might not affect 'hard' NFF funding this year but what about in subsequent years.

Our school cannot afford to take any loss to our budget, it is too great. We have to manage SEND provision in our school ourselves for the majority as the EHCP process is so long and slow. This means that we need all of our funding to support those children, this includes staffing.

This funding needs to be ring fenced as other SEN funding is not

### Reasons for 'No' responses:

Costs associated to supporting children through High Needs block funding are incredibly high with reducing services outside of school available. More funding is essential and must be diverted from elsewhere.

Funding in the Schools Block should be maximised

The school cannot afford a budget cut and it is not clear that the higher needs money is well managed.

The school cannot afford a budget cut and not is not clear how well the higher needs budget is managed.

We are facing extreme pressures from the number of FAP students who we are having to take on roll, many of whom have been permanently excluded. These students often need alternative provision or SEND support to enable them to be successful, we will use our funds for this. We are looking to expand our alternative curriculum and we use alternative provision effectively, which has prevented many permanent exclusions. We cannot afford for money to be taken out of our High Needs budget if we are to continue to develop our provision.

From our individual school's point of view neither option makes a financial difference.

I don't think the money should be transferred from school block - because we have to show the government that we do not get enough in Warwickshire in our SEND funding - if we take it from school block then school block may be reduced by the government as it is not really spare money as our schools are going into bigger deficit budgets than ever.

If we contribute, we are covering up the need for additional funding plus we don't directly impact- my budget is for my pupils.

I am unaware of how this money is going to be used in Warwickshire in schools

This action will hide a significant national issue of underfunding SEND services.

If we contribute, the true nature of the SEND funding crisis will not be evident. More SEND funding is needed in schools to support high needs children

The loss of school revenue will put severe pressure on our ability to manage budgets.



The NFF is a very imperfect system to allocate funding that delivers the MFG or below for some schools and slightly above for some others who have a significant level of other factors which require expenditure to support. This is a National problem of underfunding for all Warwickshire Schools compared to the median amount per School nationally. In an ideal world the SEND budget would be fully funded centrally and we would ordinarily support that but in the current economic climate a loss of circa £70k in terms of our School would require redundancies at the School, probably from the pastoral and SEND team who are currently dealing with a significant increased demand as Schools battle to respond to a reduction of central services and a higher threshold of need. That increasing demand is also causing significantly more stress and pressure on an already stretched team of dedicated professionals. A reduction in funding is likely to exacerbate that pressure. It is also likely that any reduction in our provision due to funding would potentially increase our call on the central SEND funding for additional alternative provision or EHCP support. It seems counter intuitive, unfair and disproportionate to penalise those Schools with significant other factors, and demands, which generates higher funding with a reduction in funding allocated when it is not required in the NFF and the subsequent impact upon those Schools whilst other Secondary Schools suffer no impact by contributing zero towards the transfer to the HNB. This seems an inequitable solution. A loss of circa £350k over our 5 years would significantly impact the viability of the School with 83% of our costs spent on teaching and educational support staff in a climate of rising staff costs and rising overheads at the same time as only a 1.9% AWPU increase being offered from the DfES for 24/25 and lower for some factors in the NFF.

Money in the schools block should be used for all schools currently, rather than cover debt of overspend of the high needs block.

The consultation document states that there is an expected gap of £11m between HN expenditure and funding by 2024/25. The proposed changes will raise an estimated £2.225m (for 0.5% transfer) or £1.127m (for 0.25% transfer. It is not clear from the consultation document how far this transfer will address the funding gap, and what other steps are being taken to address the gap if the proposed transfer does not cover the full gap. Without this information, it is difficult for our Governing Body to assess what benefits to High Needs support across the LA area, and for our Trust's school population, will result in and what action is being taken avoid the need for further transfers in future.

### In addition:

The proposed amounts are based on the incorrect DfE estimates for the NFF that have since been corrected - our Trust will be further affected with funding reduced by around £60k by our estimates.

We are already investing heavily in support and arrangements for our students with SEND and those who have non-statemented needs. The proposed transfer will put further pressure on our ability to fund this support with no clear information about how LA investment in support for mainstream settings will bring benefits to offset the increased funding pressures on our local provision.

Having consulted with our school leaders and SENCOs, we do not believe that the transfer of funds is a effective use of resources. This is because we do not believe that this would lead to schools benefiting from any increased or improved front-line SEND provision or services from the LA, leaving children worse off, and school leaders and staff in an ever-challenging situation in trying to meet needs.



With more schools going into deficit every year, unfunded teacher pay rises, rising supplier costs, growing SEN needs within our own school and preschool, time and money spent fighting for EHCPs with the LA, and barely managing to balance our budget last year for the next 3 years, our school needs all of its budgetary resource as it is. We continue to channel a lot of resource into early identification and intervention of SEN needs for children at the very beginning of their education.

The SEN funding crisis has been years in the making, and is only getting worse. Taking yet more money away from school budgets at a time when they are under the severest of strains risks pushing us, along with many other schools, into deficit.

### Reasons for 'Yes' responses:

Increased funding is essential.

I completely acknowledge the challenges the LA are under but there is real conflict between the school losing money to fund this initiative, while at the same time having an significant increase in pupils with SEN needs. With many of them not qualifying for any external additional funding. I also struggle with a perceived perception that Primary can accommodate these pupils but as soon as they get to High School age then specialist provision is the only avenue considered.

The increase in EHCP's and need across Warwickshire means further funding is needed.

Knowing how tight the high needs budget is, I believe it is fair for all schools to contribute towards this. However, all schools are also struggling and a 0.25% is a fair compromise.

The high needs block needs this financial support in order to continue provision.

From the perspective of my 3 tiny schools, a drop in funding of only a few thousand does affect our ability to provide adequate support for all pupils, both those with and without special needs. The NFF has (on the whole) had a positive effect on small schools, so anything that threatens that upward trend is concerning. Of course, we all want adequate funding for EHCP children, and places in resource provision for those children who would benefit, but my answer to this question is selfishly being driven by the context of the budgets in my schools.

Very High level of SEND requires more funding.

I recognise the need for additional funding and the document presents the need well but I also know that schools still bear the brunt of the majority of funding for SEND. The funding from an EHCP does not cover the additional spend needed and there are MANY students for whom we do not get additional funding yet their needs require additional money in order to support them i.e Dare to dream is being heavily promoted by WCC but at a cost of £250 per session it is very costly. To meet this spend money must go to to schools therefore I support the 0.25 transfer as this supports WCC whilst also recognising that schools require money to fund the support of a growing number of students.

Our school cannot afford to take any loss to our budget, it is too great. We have to manage SEND provision in our school ourselves for the majority as the EHCP process is so long and slow. This means that we need all of our funding to support those children, this includes staffing.

Most LSA are paid through high needs funding anyway

### Reasons for 'No' responses:

School budgets are stretched to the limits. This cannot impact on them - there needs to be a separate funding stream.

No - not fair and equitable for other recipients of this funding.

Funding in the Schools Block should be maximised

If we contribute, we are covering up the need for additional funding plus we don't directly impactmy budget is for my pupils.

I am unaware of how this money is going to be used in Warwickshire in schools Reduction in funding will not enable schools to support SEND provision.

I am unsure but there is not an option. It depends on the govts publication of funding per pupil which has not been finalised

Money in the schools block should be used for all schools currently, rather than cover debt of overspend of the high needs block.

Having consulted with our school leaders and SENCOs, we do not believe that the transfer of funds is a effective use of resources. This is because we do not believe that this would lead to schools benefiting from any increased or improved front-line SEND provision or services from the LA, leaving children worse off, and school leaders and staff in an ever-challenging situation in trying to meet needs.

With more schools going into deficit every year, unfunded teacher pay rises, rising supplier costs, growing SEN needs within our own school and preschool, time and money spent fighting for EHCPs with the LA, and barely managing to balance our budget last year for the next 3 years, our school needs all of its budgetary resource as it is. We continue to channel a lot of resource into early identification and intervention of SEN needs for children at the very beginning of their education.

The SEN funding crisis has been years in the making, and is only getting worse. Taking yet more money away from school budgets at a time when they are under the severest of strains risks pushing us, along with many other schools, into deficit.

### Reasons for 'Yes' responses:

Up to 2% if possible

0.1% or any points below 0.25%

A much higher percentage with 20% on SEN register and 6% with an EHCP this should be factored into mainstream school budgets and allocation of funds.

Unsure - further information is needed about the impact of the corrected NFF estimates, and further information about how the £11m funding gap will be addressed beyond using transfers from the Schools Block and clarity on the benefits that a funding transfer could bring to support in mainstream settings through improvements in support and co-ordination.

### Reasons for 'No' responses:

At this stage I feel we are in a better position to use our High Needs funding to support our students and those that we take to support the wider network of schools. However, schools should have enough notice of changes to plan their budgets accordingly.

I would be nervous of saying anything! We need so much more money on SEND budget - mainstream schools with a high number of EHCP's cannot manage. I need guarantee that funding is for the children that need it whatever school they go to!

More funding for SEND is desperately needed. Any reduction will severely impact the provision that can be provided.

I don't know so have responded no

If money was to be transferred then it should not be on a percentage basis but on a contribution basis with all Schools in each key stage pay the same flat fee contribution or that the maximum any School can pay is capped at an affordable level. Applicable to all Schools regardless of impact upon the MFG position. Preferably for all the reasons stated it would be best to leave the funding devolved to the Schools to manage their SEND and pastoral support appropriately.
