Forward plan for sub-recommendations of JSNA

October 23 – April 24:

Getting Risk Support recommendations

- Targeted approach to self-harm in females age 13-18.
- Development of systemwide approach to identifying those at risk of self-harm.
- Joined up approach to suicide awareness between communities and services, including those who do not specialise in MH.
- Place partnerships to accelerate work to address self-harm as part of delivery of the C&W suicide prevention strategy.
- Targeted comms and health promotion around the risk of household medicines as a means for self harm and potentially suicide.
- Development of wrap-around support service for children and families at risk of entering crisis, with system for early identification and intervention.
- Co-production of guidance for those (including friends, parents, siblings, carers) who have concerns about a child or young person at risk of self-harm or suicide.

Forward plan for sub-recommendations of JSNA

May 24 – October 24

Getting Advice, Help, and More Help recommendations:

- Development of a universal access drop-in offer across county and various settings (incl schools).
- Review of whole family offer and consideration of peer-support and dropin parenting programmes for parents and carers of CYP with MH issues.
- Co-produced information offer across digital/social medial platforms. Info should be consolidated, promoted and easy to access.
- Needs and gap analysis of MH services for CYP, including identification of service touch points.
- Engagement with CYP transitioning into Adult Services to understand needs and gaps.
- The recommendations from this JSNA need to be read in conjunction with the Coventry and Warwickshire Trauma Needs Analysis recommendations.

Local Context recommendations

- The use of HEAT in commissioning and planning decisions to ensure good access to meet needs of the population which is growing in diversity.
- Joined up working with universities to support needs of student population navigating transition from Child to Adult services.

Nov 24 – March 25

Thriving recommendations

- Mentally Healthy Schools recommendations to support delivery of health promotion around risk factors affecting mental health.
- Children should be included and involved in finding the solutions to issues that impact them.
- Social prescribing should be expanded to all children and young people at the earliest signs of need.
- Assessment of current pathways for access to MH support for children with Life-Limiting conditions (LLCs).
- Child in need assessments, and associated carers assessments should be offered to children with LLCs, using an LLC checklist.
- Utilise system working to commission services to address the current gap in provision for pregnant teenagers who require mental health support.
- Improved data and intelligence collection at a locally.
- Support for childcare services to facilitate return to pre-pandemic availability levels.
