27 November 2024	Update from University Hospitals Coventry and Warwickshire (UHCW)	UHCW will give an update on service developments at the St. Cross Hospital in Rugby and the recent closure of the Hoskyn ward at this hospital.
27 November 2024	Quarter 2 Integrated Performance Report 2024/25	For the Committee to consider and comment on the Quarter 2 Integrated Performance Report 2024/25.
22 January 2025	South Warwickshire Community Beds Review	For the Committee to consider the formal consultation on the South Warwickshire Community Beds review.
22 January 2025	Step down bedded care provision in Rugby and the North of Warwickshire	The Coventry and Warwickshire Integrated Care Board (C&W ICB) will brief the Committee on the arrangements in these two areas of the County when people are discharged from an acute hospital but need ongoing care before returning to their permanent home.
26 February 2025	NHS Bowel and Bladder Service	A follow up to the presentation at the Committee in April 2024. This will be a joint item from the Coventry and Warwickshire Partnership Trust and the C&W ICB.
9 April 2025	Menopause Services – Progress on Actions	In April 2024, the Committee approved the report of the Menopause Services task and finish review. This item is to monitor progress on the implementation of the review's recommendations.
Date TBC	Health Visiting Service	For the Committee to receive an update on the Health Visiting Service from Public Health.
Date TBC	Right Care, Right Person	Arising from consideration of the community mental health transformation in September 2024, it was proposed to receive information on this police initiative which aims to reduce the amount of police time spent supporting people in mental health crisis.

Date TBC	Joint Coventry & Warwickshire Health Protection Strategy	The joint Coventry & Warwickshire Health Protection Strategy will review the data and evidence available around health protection needs across Coventry & Warwickshire, consider where Coventry & Warwickshire fall below national targets and make appropriate recommendations to mitigate. The strategy is a joint piece across Coventry & Warwickshire, involving a wide range of partners.
Date TBC	Review of Learning from the Covid Pandemic	This will be a joint meeting with the Children and Young People OSC. The scope is to be finalised at the Chair and spokesperson meeting but concerns the learning which could be drawn from the pandemic to assist with responding to any future pandemic. It could also provide a focus on required activity now to respond to differences seen over the last two years.
Date TBC	Annual Health Checks	This item concerns GPs undertaking an annual health check for patients with a long-term mental illness. At the Committee in April 2024, it was agreed to link this item with Healthwatch's work with veterans about accessing annual health checks.
Date TBC	Direct Payments	Added to the work programme in October 2023. A low proportion of older service users are opting to receive a direct payment. There are a number of contributors, and many are opting for domiciliary care instead. The item could include promotion of the service and career potential, national and focussed recruitment efforts. Also, the challenges in securing care at a reasonable price, and making it easier for people to use the direct payment option.
Date TBC	People aged over 65 supported in a residential or nursing care placement	Added to the work programme in October 2023. A challenged area with an increasing trajectory of service need based on population health with an associated budgetary impact.
Date TBC	Stroke Services	Added to the work programme in October 2023. Generally, the revised pathway seems to be going well. Areas of focus to include ambulance response times, whether all suspected stroke patients are taken direct to the hyperacute stroke unit at University Hospitals Coventry and Warwickshire, whether other acute trusts had patients arrive at their A&E departments, and onward care in community settings after hospital discharge.

Date TBC	Patients Presenting at Emergency Departments needing Mental Health support.	Added to the work programme in October 2023. This concerns patients (both adults and children) presenting at A&E or the emergency department with mental health problems (and no physical health conditions), the length of wait before transfer to a more appropriate service and the support available.
