Summary of Matter	
As part of its response to Coronavirus the Government has passed The Health Protection (Coronavirus, Restrictions) (England) Regulations 2020.	
The Regulations state that a local authority may designate a person(s) under Regulation 8 (Enforcement of Requirement) in relation to a requirement in Regulation 4 (Requirement to close premises and businesses during the emergency) or Regulation 5 (Further restrictions and closures during the emergency period).	
The Government guidance that has been published states that 'Environmental Health and Trading Standards officers will monitor compliance with these regulations, with police support provided if appropriate'. This can be viewed at https://www.gov.uk/government/publications/further-businesses- and-premises-to-close/further-businesses-and-premises-to-close- guidance	
To lawfully enable the officers of the Trading Standards Service to enforce the Regulations it is first necessary for the County Council to designate such officers under Regulation 8 (Enforcement of Requirement) and Regulation 10 (Fixed Penalty Notices).	
The Regulations are made under the Public Health (Control of Disease) Act 1984. Adding the Act to the list of legislation delegated to the Strategic Director for Communities and his/her nominees in the Trading Standards section of Part 2 Section 10 of the County Council constitution will enable officers to be designated to enforce the Regulations and enable the Trading Standards Service to institute legal proceedings under regulation 9 in appropriate circumstances. Delegation of the Act will means that the Trading Standards Service will be able to discharge any additional functions imposed by the Government under the Act in the future without further reports and delegations.	
It is appropriate that this report should be dealt with under the Urgent Decision procedure in the County Council Constitution to allow enforcement of the Regulations as soon as possible.	

Proposed Decision
